It was felt that under the prevailing situation in the Institute, the requirement for full time incumbent on key positions has been felt immensely and accordingly it was decided that permission may be sought from the Ministry to fill these positions through advertisement. In the absence of regular Director, Ministry may be requested to permit Chairman, BoM as the Chairman of the Selection Committee for these posts, in the interest of the Institute as a onetime measure.

# ITEM TO REPORT ABOUT INDEFINITE HUNGER STRIKE AND NO. PROTEST BY BOTH THE NON-TEACHING ASSOCIATIONS OF 26.07 SLIET

The matter was deliberated at length. The memorandum submitted by the SEWA was also discussed alongwith reply of the institute. It was observed that issues raised by SEWA lacks merit as the same was against the facts on record.

The DEA (T) suggested that the institute may resolve such crisis strictly under the provision of MoA in order to avoid legal complications and repercussions.

## DISCIPLINARY CASE REGARDING MAPPING OF PUNJAB PAY SCALE WITH CENTRAL PAY SCALES AGAINST FOUR OFFICIALS

Prof. Sanjay Marwaha, Officiating Registrar, who is non-member presenting officer, requested that since this is a crucial matter and it should be placed in next Board of Management Meeting as the primary agenda and should be deferred for the time being. However, all the Board members were of the view that being crucial issue, pending decision for the last more than one year, this cannot be deferred till next BoM. Shri Mohanbir Singh, Additional Director raised some queries on the involvement of Shri Amarjit Singh, Shri Harmesh Singh, Dr. S.S. Dhaliwal in the concerned case. Director, SLIET explained in detail the involvement of three officials in the concealment and suppression of facts in this case, which has resulted into many disparities of pay scales, which is evident from the cases filed by about 130 employees seeking parity in the pay scales as extended to employees on the basis of mapping. Some of the members were of the opinion that minor penalty should be imposed on the

concerned officials whereas most of the others were of the opinion that concealment of facts is a major offense and therefore the major penalty should be imposed. The matter was deliberated at length and keeping in view the facts regarding concealment and suppression of facts as pointed out by the inquiry Committee led by Hon'ble Justice (Retired Sh. Amarjit Singh Katari), it was unanimously resolved that:

Penalty of compulsory retirement imposed by the institute on 10.4.2017 with all service benefits to Sh. Amarjit Singh, Section Officer for the concealment and suppression of facts from the Institute and Ministry, which led to wrong mapping being done, was noted.

Similar Penalty of compulsory retirement be imposed with all service benefits to Sh. Harmesh Singh, Assistant Registrar for the concealment and suppression of facts from the Institute and Ministry which led to wrong mapping being done.

Minor Penalty of Censure for being indicted of unintended commission has been imposed on Dr. S.S. Dhaliwal, Professor (Mathematics).

The meeting ended with a vote of thanks to the chair.
