ITEM NO. CONFIRMATION OF THE MINUTES OF 27th MEETING OF 28.02 THE BOARD OF MANAGEMENT HELD ON 01.12.2018.

The BoM confirmed the minutes of 27th meeting of the BoM. In course of confirmation of 27th BOM with the aspect of payment of salary based on 7th CPC was discussed. It was informed to the BOM that salary as per 7th CPC has been released to all employees (teaching & non-teaching) except 24 non-teaching employees who switched over from Punjab pay scale to central pay scales.

It was resolved that all non-teaching employees are eligible for grant of 7th CPC, except one drawing Punjab pay scale. However, in light of the history of litigation, the BOM desired that the following **CALCULATIONS** be made for 24 non-teaching employees who switched over from Punjab pay scale to central pay scales:

- (i) Fixation of basic as drawn on 31.12.15 in 7th CPC, assessment of basic which ought to have been fixed based on April 16, 1999 letter of MHRD.
- (ii) Un-doing the incorrect mapping done based on MHRD letter No. F. 10-34/2008 TS IV (Pt.) dated 8th /15th March, 2011. This will involve doing the correct mapping which will accordingly re-fix the salary in 6th CPC [which say comes out to be "Y"].
- (iii) This "Y" be remapped on 31.12.15 in 7th CPC.

These calculations are to be presented to MHRD, New Delhi.

ITEM NO. REVIEW ON ACTION TAKEN REPORT ON THE MINUTES 28.03 OF 27th MEETING OF THE BOARD OF MANAGEMENT HELD ON 01.12.2017.

The BoM observed that the institute should provide an action taken report at each meeting. Even if it was work in progress. The BoM asked the institute to expedite the action taken and present the same in the next BOM meeting as well as ensure it is presented at subsequent meetings as well.

ITEM NO. TO RATIFY GRANT OF FINANCIAL UP-GRADATION UNDER 28.04 MACP/ACP SCHEME

The Board enquired if the institute could certify that these employees have been recruited in central pay scales and fulfil the criterion of MACP/ACP scheme of Government of India. Since it was not possible to do so. The Board directed that all such cases should be brought to the board for ratification only if the institute was willing to certify that the due process has been followed and the recommendations are correctly recorded.

3.11.3: Irregular Purchase of Computers

Approved. The institute will ensure that all purchases are made strictly as per provisions of GFR-2017/GeM portal. The purchase of computers made in 2003 is regularized to settle the audit para.

However the suggestions relating to the enquiry proceedings would need to be bought as a separate agenda item.

3.11.5: Unauthorized Possession of Staff Quarters

The un-recoverable amount of Rs. 2,96.000.00 (Rs two lacs ninety six thousand only) is written-off.

3.11.6: Avoidable Payment of Electricity Duty

Noted. Institute needs to obtain the letter for refund of the said amount from PSPCL.

The institute was advised that action taken against CAG para's need to be uploaded on the CAG Website as per procedures prescribed.

The institute was instructed to report to the board the action taken.
