TO APPROVE THE INSTALLATION OF SOLAR POWER PLANT OF 100 KW CAPACITY AND SOLAR WATER HEATERS IN HOSTEL BUILDINGS AT SLIET LONGOWAL

Provision of ₹. 2.00 crore was made in the budget requirement for 2013-14 for Installation of Solar Power Plant of 100 KWP capacity and ₹. 20.00 Lacs in 2012-13 budget for replacement of Electric Water Heaters in all the Hostels with Solar Water Heaters at SLIET, Longowal.

The Ministry of New & Renewable Energy (MNRE) Regulations, allow 30% subsidy for installation of Solar Power Plant of 100 KWP and Solar Water Heaters. As budget provisions have already been made in the Financial Year 2012-13 and 2013-14, approval may be accorded for installation of Solar Power Plant of 100 KWP and replacement of Hostel Electric Water Heaters with Solar Water Heaters in the Institute. These are proposed to be carried out through Top rated MNRE Channel Partners of MNRE.
