RE-CONSIDERATION AND CONTINUATION OF THE PROJECT ACTIVITIES UNDER THE ENTREPRENEURSHIP AND MANAGEMENT DEVELOPMENT PROGRAMME (EMD) SCHEME FOR THE FINANCIAL YEAR 2015-16.

A project under EMD scheme was sanctioned by AICTE in the year 2001-02 to the Institute with a balance of grant for Rs. 10.5 Lacs (Recurring Rs. 6.50 Lacs and non recurring Rs. 4.00 Lacs) up to the year 2006-07. The project was assigned without any tenure. During the year 2011-12, it was decided that the project may be closed and balance unspent amount may be sent back to the funding agency.

The main objective of the Institute in undertaking the project has been the entrepreneurship and skill development. The Institute has adopted new academic structure system having a provision for providing in-house training. At present, a balance amount of Rs. 5.31 Lacs approximately under the project is lying unspent. It is proposed to revive the project and recommence the project activities under EMD scheme during the year 2015-16. The action plan for the year 2015-16 is enclosed herewith **at Annexure-"F" from Page No. 125 to 131.**

CONDEMNATION, WRITING OFF AND DISPOSAL OF THE EQUIPMENTS IN THE DEPARTMENT OF COMPUTER SCIENCE & ENGINEERING (CSE) WORTH Rs.2,32,54,632.00 AND \$55475.00 REQUIRING RATIFICATION OF BOM.

The Head of Computer Science and Engineering (CSE) Department initiated a proposal on 21.01.2015 to write-off the equipments lying in the department as "Not Working & beyond economic repair." The proposal was taken-up by the Institute Central Write-off Committee constituted by the Director vide circular no.: SLIET/C.Store/290-293, dated 16.03.2015. The Central Write-off Committee has submitted its recommendations **at Annexure-"G" from Page No. 132 to 161.**

Based on the recommendations of the Institute Central Write-off Committee for condemnation, writing off and disposal of equipment having the bookvalue of Rs.2,32,54,632.00 and \$55475.00, the Director has recommended placing the matter before the BOM, through the Finance Committee.
