Since, the experts delivering lectures in the Symposium/ Seminars/ Conferences present their work/views for better interaction among the scientific community, they are not entitled for Sitting Fee which is usually given to those experts who are invited for their opinion in the committee or meeting. Also, the Chief Guest/Guest of Honour are the eminent

personalities who are invited for sharing their experience and presenting their views in any Institute function (may be any Conference/Techfest./Cultural Programme etc. . They should also be not allowed to get Sitting Fee from the Institute. Accordingly, the Sitting Fee may be allowed only for the followings:-

For members of SLIET Society/BOM/FC/ B&WC/ Selection Committee/Board of Studies/ Senate/Academic Council/experts for conducting Viva-Voce coming from outside the Institute.
