PN/20980 AMOUNTING TO RS. 10,45,525=00 DIRECTLY BY QUASI-JUDICIAL ORDER BY ASSISTANT PROVIDENT FUND COMMISSIONER, CHANDIGARH THROUGH GRANT-IN-AID ACCOUNT NO. 540 OF THE INSTITUTE AT CENTRAL BANK OF INDIA, SLIET CAMPUS, LONGOWAL

Dean (P&D) has informed that an advocate of Sangrur has been hired to file First Information Report (FIR) against M/s Roving Eyes Security & Intelligence Service, Patiala and M/s Punia Security Services, Sangrur on behalf of the Institute. Sh. Harmesh Singh, Assistant Registrar (Admn.) was deputed by Dr. S.S. Dhaliwal, Registrar to the Police Station, Longowal alogwith a letter addressed to Station House Officer (SHO) for lodging FIR against the defaulting Firm(s). SHO, Longowal was to make some preliminary inquiry as a normal course, before lodging FIR. After confirmation of preliminary inquiry, as reported by the Registrar on telephone, SHO, Longowal will register/lodge FIR accordingly. A Legal Notice has, therefore, been sent to these contactors for recovery of EPF paid by the Institute, who have not deposited the same in EPF Office. A copy of the same has also been sent to concerned Police Officers for taking further course of action, in this regard. Further, it is informed that in compliance of order in 35th Finance Committee meeting at Item No. 36.02, Institute has written two letters on 04.04.11 and 11.05.11 to Branch Manager, Central Bank of India (CBI), SLIET, Longowal against which the reply of Senior Manager, CBI, SLIET, Longowal dated 14.05.11 was received to the Institute which was adjudged as undesirable because the transfer was required to be made after seeking the consent of the Account Holder first or, informing to the Account Holder prima-facie, before remitting the amount to Regional Provident Fund Commissioner, Chanidgarh. Such step of directly remitting the amount without taking the permission of the Account Holder had been viewed seriously. Since the Branch Manager, CBI, SLIET, Longowal is not under direct administrative control of the Institute, a letter of concern has been written to the Regional Manager, CBI, Ludhiana, with a copy to Zonal Manager, CBI, Chandigarh, making a request to take immediate administrative suitable action against the Branch Manager, CBI, SLIET, Longowal, so that the recovery of remitted amount may be made possible to the Institute immediately, without further loss of time and such undesirable act by Branch Manager, CBI, SLIET, Longowal may not occur/recur in future. And, the Security Money alongwith the Earnest Money Deposit (EMD) of M/s Roving Eyes Security & Intelligence Service, Patiala, already deducted by the Institute, from their monthly bills has been forfeited/adjusted on 29.04.2011 for Rs. 5,98,754=00.
