WALK IN INTERVIEW ON 11/09/2014

The Institute is an Autonomous Centrally Funded Technical Institute (CFTI), fully funded by Govt. of India. - * NET/SLET/SET shall remain the minimum eligibility condition for recruitment and appointment of Assistant Professors. *Provided* however, that candidates, who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent position.
- * NET/SLET/SET shall not be required for such Masters Degree Programmes in disciplines for which NET/SLET/SET accredited test is not conducted.
- * *A relaxation of 5% may be provided at the Graduate and Master's level for the Scheduled Caste/Scheduled Tribe/Differently-abled (Physically and visually differently-abled) categories for the purpose of eligibility and for assessing good academic record during direct recruitment to teaching positions.* The eligibility marks of 1st class (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedures.
- * Relevant grade which is regarded as equivalent of 1st class wherever the grading system is followed by a recognized university shall also be considered eligible.
 - **For Engineering Departments:** The candidates with B.Tech. and M.Tech. 1st Division in both, in the appropriate Branch of Engineering/Technology.
 - **For Science Departments:** B.Sc and M.Sc. with 1st Division in appropriate discipline of Sciences with NET qualified.

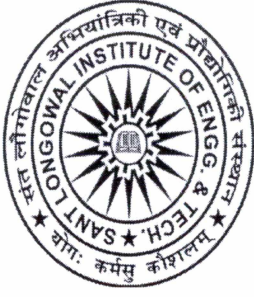
