clients must be enclosed, an undertaking indicating that industry standards shall be followed as to the quality of products must be enclosed duly signed and Commercial Bid in two different envelopes (one for Price Bid another for Technical Bid) clearly marking the contents on the outside of each envelop and these envelopes to be sealed in a single big envelop indicating envelopes contained in it. Commercial bids of only those bidders will be opened subsequently who will qualify technically. Technical Bid must also include the offer for AMC after expiry of warranty period for the complete system. Bidder must mention in the technical bid about the site preparation (if any), needed from SLIET, Longowal for the execution of the proposed work.

2. Technical Bid must contain list of items, quantity & make for each item. Commercial Bid/Price Bid contain the price of each item mentioned in the technical bid, amount and the total value of the solution as per above requirement. Price for complete solution once quoted shall be final. In case of addition/deletion of work, the payment will be made as per rates offered for each item. The quote must be complete in all respects, i.e. all the items required for the complete solution should be taken into consideration, failing which the offer may be cancelled.
3. The **CCTV Surveillance Support Team** of SLIET, Longowal will assist the bidders in performing the site survey to determine the scope of work on a particular day fixed by the institute for the purpose of **pre-bid conference**.
4. It may be noted that quotation must be sent on the letter head of the party by Indian Post Office only (Preferably by Speed Post). The institute is located in remote area and it takes 5 to 7 days to reach the mail, therefore, quotation be dispatched well in time considering this factor.
5. Rate of ST/VAT if extra must be mentioned clearly.
6. Price quoted must be FOR SLIET.
7. Quotation received later than 03.00 P.M. on due date are liable to be rejected.
8. The terms and conditions for submitting the quotation are enclosed herewith which must be carefully read before submitting the quotation.
