## OFFICE ORDER

All the RTI applications are required to be routed through Nodal Officer, RTI, who will then send the same to CPIO and First Appellate Authority. The CPIO, SLIET will process the online application through DPIO/APIO and reply back to the applicant.

To comply with the instructions of the DoP&T, Government of India, New Delhi regarding implementation of online RTI Portal in the SLIET and to deal the RTI effectively, the competent authority has approved the following RTI Authorities of the Institute.
