- **3.** i) An item rate tender containing percentage below/above will be summarily rejected. However where a tendered voluntarily offers a rebate, this may be considered.
 - ii) Tender shall be strictly as per the condition of contract, conditional tenders are liable to be rejected.
- 4. i) Special care should be taken to write the rate and amounts in figures as well as in words in such a way that interpolation is not possible. - 6. The acceptance of a tender will rest with the Director, SLIET who does not bind himself to accept the lowest tender, and reserves to himself the authority to reject any or all of the tenders received without the assignment of any reason. The decision of Tender Opening Committee will be final in case of any dispute during Tender Opening Process. All tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.
- 7. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer-in-charge shall be intimated to the undersigned.
- **8.** Canvassing in connection with tenders is strictly prohibited and the tender submitted by the contractors who resort to canvassing will be liable to rejection.
- 9. - **10.** The bidder has to provide warranty for the items like ceiling fans, exhaust fans, geysers, fresh air fans, wall fans, CFL, Compressor for the period minumim one year or as per manufacture of norms in lieu of the same.
