The Terms & Conditions for submitting quotation are as under:-

- 1) It may be noted that quotation received through registered/speed post only shall be considered. The institute is located in a remote area and it takes 5 to 7 days to reach the mail, therefore, quotation be dispatched well in time to avoid any sort of delay.
- 2) Rate of GST, if extra, must be mentioned clearly.
- 3) Quotation other than those addressed to Deputy Registrar (S&P) will not be entertained.
- 4) The Price quoted must be FOR SLIET, Longowal including installation.
- 5) Quotations received later than due date will not be accepted.
- 6) Duly signed quotation must be sent on the letter head of the party.
- 7) As per instructions, if purpose of quotation is not super scribed on envelop and quotation is opened by mistake, then it will be rejected.
- 8) Quotation must be valid for a period of 3 months.
- 9) The other terms & conditions for submitting the quotation are given "**Annexure-B**" which must be read carefully before submitting the quotation.

Terms & Conditions

1. The defects, if any shall be attended to on immediate basis but in no case any defect should prolong for more than 24 hours.
2. The service coverage will be from 8:30 AM to 5:30 PM (Monday to Saturday or 6 days a week) or beyond the office hours as and when required.
3. You will support the site with an onsite resident engineer with the proper technical knowledge of the equipment.
4. The resident engineer has to configure the networking equipments as and when allotted by SLIET.
5. The resident engineer should have all the testing equipments & tools (Laptop, LAN Tester, Crimping tool, Screw Driver, Punching Tool) or any other tools required during the AMC period without any additional charges. Institute will not provide any equipments & tools to your resident engineer
6. Any type of work can be assigned to resident engineer by the SLIET authority.
7. If SLIET authority is not satisfied with the services of the resident engineer, the company has to provide another resident engineer within 1-2 days.
8. The resident engineer has to mark the attendance in the office.
9. The resident engineer can avail a total of 08 Casual leave (CL) per year with prior permission of the office bearer. No other type of leave will be given. If more than 8 Casual leave (CL) is availed, the company has to provide the substitute engineer in such case, in case of no substitute is provided the per day cost of total AMC cost will be deducted from the final AMC payment of the company.
10. The company will be liable to any misconduct by the resident engineer in the SLIET Campus.
11. Observance of Labour Laws: The successful bidder will be solely responsible for the applicability and observance of all labour laws and other legal requirements. The institute shall be at liberty to ask for removal/ transfer of any person of the party/ successful bidder.
12. Liability of the Institute: The Institute shall not provide any residential accommodation to the personnel employed by the Agency except to resident engineer. However, the accommodation can be provided to resident engineer, on payment basis, only subject to availability of accommodation. The Institute will be under no legal obligation to provide employment to any of the personnel of the Agency after expiry of tender/agreement/contract period and the SLIET recognizes no Employer-employee relationship between SLIET and the personnel deployed by the Agency. The Institute shall not be responsible financially or otherwise for any injury during the technical support period.
13. Arbitration: In case of any dispute or difference arising out of or in connection with this contract agreement or the implementation or interpretation of any of the clauses of this agreement, the matter will be referred to the Sole Arbitrator to be nominated / appointed by the Director SLIET, Longowal. The decision of the Arbitrator shall be final & executable and binding on both the parties. The fee of the Arbitrator appointed shall be determined by Director SLIET and both the parties at dispute will pay fee to Arbitrator in equal proportion.
14. Payment will be made on per year basis.
