





TERMS & CONDITIONS FOR QUOTATION



Penalty	The supply must be completed satisfactorily within the stipulated period, failing which penalty @ ½ % per week on the value of supply order or part thereof whichever is lower (subject to maximum 5% of supply order value) will be imposed without any notice
TERMS OF PAYMENT	Our normal terms of payment is within 30 days after receipt of stores in good condition by means of ECS after submission of Tax invoice & Bank Details
TAXES	GST TDS will be deducted @2% from the Bill amount (if applicable) & any other Govt. levy as applicable will be made accordingly.
