- 10. Successful Bidder is to provide Structural Drawings, if required.
- 11. The contractor shall also ensure compliance of the EPF & MP Act, 1952 by the Sub-contractor, if any engaged by the contractor for the said work and any sub-contractor engaged should also have Provident Fund Code.
- 12.
