
The annual maintenance contract is subject to the following term and conditions.

1. AMC will consist of 02 preventive & 02 breakdown visits if and when required in the year without additional cost. Instrument shall be inspected and tested at reasonable spaced interval. Preventive service will include the general maintenance, troubleshooting, alignment and calibration of the equipment & application support etc. when considered necessary.
2. Engineer will visit institute within 02 working days after receipt of breakdown call/intimation. Visit will be deemed complete only after satisfactory working of equipment.
3. Spares/consumables required for repair are to e purchased separately at extra cost.
4. Payment term: 50% payment of AMC will be released after 1st preventive service in the first quarter of the year and remaining 50% will be released in the 4th quarter.
5. Invoice/bill must show the same description as given in the supply order.
