Sant Longowal Institute of Engineering & Technology (SLIET), Longowal, Sangrur (Punjab)-148106 is an autonomous body spread over 451 acre, fully funded by Govt. of India, New Delhi. The Institute was established by Ministry of Human Resource and Development (MHRD), Govt. of India in the year 1989 and was formally inaugurated on 20th December 1991.

The Institute intends to empanel approved/authorized fuel pump from IOC/HPCL/BPCL etc. located at a distance of 7 KM from SLIET Main Bus Stand for the procurement of Diesel for the vehicles/DG sets & other equipments. This empanelment will be valid for 2 years & same can be extended for one year more subject to the satisfactory performance of the supplier.

TERMS & CONDITIONS

1. The Institute shall issue slips for procurement and the same slips will be issued by the authorized signatory.

2. This discount will be valid for two years from the date of contract assigned to the successful bidder.
3. The Vendor will raise the bill on a monthly basis.
4. The payment will be made within 10-15 working days from the receipt of the authenticated computerized bill duly supported with RTGS/NEFT detail & the issue slip duly signed by the authorized signatory of the Institute.
5. The vendor will ensure that there is no adulteration in the material supplied and the quantity supplied is strictly as per the issue slip. In case any adulteration and short supply is noticed, empanelment shall be cancelled and the matter will be reported to IOC/HPCL/BPCL etc. The Institute shall have the right to impose penalty in such cases. The decision of the Director, SLIET, Longowal in this regard shall be final.
6. The Director, SLIET reserves the rights to accept/reject, any or all offers submitted in response to this Advertisement without assigning any reason thereof.
7. Director, SLIET has full right to cancel/withdraw this tender or empanelment after vender is appointed at any time without assigning any reason.
8. The Institute will lift the material from the fuel Pump at own cost.

4. Offer must be submitted on Letter Head of the firm with all particular. Any other format will not be acceptable.
5. The offer of empanelment will be awarded to the successful supplier by the Institute who will offer maximum percentage discount on the said items.
