17. Only minimum one-year continuous full time service in an organization/Institute will be considered/counted towards experience.
18. Those who could not send their applications through proper channel within the last date have to produce NOC from their employer at the time of interview.
19. In case of any typographical mistake/clarification, the decision of the Director of the Institute will be final.
20. In case of any legal dispute, it is subject to the courts of Sangrur/High Court of Punjab & Haryana at Chandigarh
