MCI recognized MBBS/BAMS/BHMS with PG degree/ PG Diploma in concerned Specialty (for allopathy).

2. QUALIFICATION AND EXPERIENCE FOR PSYCHOLOGICAL COUNSELOR.

MA/M.Phil/ M.Sc. / Ph.D. in Counselling Psychology/ Clinical Psychology, with a minimum 55% marks in qualifying exams and one-year relevant experience in the respective area after the qualifying degree.

Desirable – Counselling adolescents of age group of 16-22 years.

3. QUALIFICATION AND EXPERIENCE FOR PHYSIOTHERAPIST.

BPT degree/MPT degree with one-year relevant experience in the respective area after the qualifying degree.

The physiotherapists must be registered with the Health and Care Professions Council (HCPC).

4. PERIOD OF ENGAGEMENT

The initial Engagement will be for a period of one year. Further, extension of Engagement, as per Institute's policy, may be considered based on performance of the Visiting Consultant and upon requirement of SLIET.
