At the outset, **Prof. Shailendra Jain**, Director SLIET, welcomed Hon'ble Chairman, BoM **Dr. K Radhakrishnan**, and all the members of the BoM. He welcomed **Dr. Neeraj Saxena**, Advisor-I, AICTE, as a new member of BoM, and extended thanks to outgoing member **Prof. Dileep N. Malkhede** for his contribution as BoM member.

Further, Director, SLIET informed the Board that the term of two members of the Government of Punjab (Prof. Buta Singh Sidhu, VC, MRSSTU, Bhatinda and Principal Secretary, Govt. of Punjab, Department of Technical Education & Industrial Training) completed on 15<sup>th</sup>Jul 2022. The institute already requested Govt. of Punjab for the nomination of new members,vide letter no. SLIET/Admn./A2/175, dtd11<sup>th</sup>Apr 2022, followed by two reminders on 05<sup>th</sup>Aug 2022 and 12<sup>th</sup>Oct 2022. The reply is still awaited from the Government of Punjab for the same.

BoM deliberated on this issue and **resolved** that these members shall continue to be members of the BoM, till a new nomination is received from the Government of Punjab, in the larger public interest, as it is vital for the institute to continue its activities for its growth and smooth functioning.

Further, **Shri M.M. Singh**, Director, TS-7 Cell, MoE, informed the Board that vide MoE orderF.No.10-7/2021-TS.VII(Part file), dtd 28<sup>th</sup> Oct 2022, the tenure of **Prof. Shailendra Jain**, present Director, SLIET, has been extended beyond 2<sup>nd</sup>Nov 2022, for another period of six months or till the appointment of new Director whichever is earlier. The same was noted by the Board.

Then, Director SLIET requested **Chairman BoM** for his opening remarks. After that, the Director requested the Registrar, Presenting Officer, to initiate the proceedings of the meeting.
