- **1.2.** The Law Firm shall be responsible for drafting/vetting of all kinds of documents/Agreements whatsoever required, in consultation with the Sant Longowal Institute of Engineering and Technology and maintenance of records of patents, industrial designs, trademarks, copyrights and Semiconductor Integrated Circuits Layout Design etc.
- 1.3. Law firm shall provide Patent Searches, Invalidity/validity and State of the Art Search.
- **1.4.** Handling aspects such as renewal, opposition, revocation and restoration of IP and any other proceeding under relevant IP Act/Law including IP management matters in India and Abroad.
- **1.5.** Maintenance and handling of foreign patent application (including PCT) for filing/IP securing.
- 1.6. Interaction (if required) with inventors/ principal investigators (PIs) and applicants.
- 1.7. IP infringement cases, representation in India and miscellaneous actions under the relevant Act.

2. Tenure of Engagement:

The tenure of engagement of panel (minimum 01 firm) shall be initially for a period of two years, extendable further up to four years on yearly basis with same terms and conditions, depending upon the satisfactory performance of the Law Firm.

3. Eligibility Criteria:

The firms should fulfill the following criteria and should produce documentary evidence wherever applicable, including the experience projected etc.:

- Firms should be a legal entity registered under statutes of India and should registered patent agent with Indian patent office.
- Firm should be of good standing with minimum experience of 05 years with some working experience with public sector R & D entities/organizations dealing with all types of IP including services for Patents, Designs, Copyrights, Integrated circuits layouts, Trademarks & Service Marks etc.
- The firm should not be blacklisted by any Central/State Government/ Public Sector Undertaking, Govt. of India and should not have litigation that may have an impact on the delivery of services.

4. Documents Required:

Proponents are requested to go through all pre-qualification requirements, scope of work for execution & requirements w.r.t. Technical/Financial capabilities and to submit all relevant documents. Sant Longowal Institute of Engineering and Technology, reserves the right to call for any clarifications as required to assess the company for eligibility.

5. RejectionCriteria:

The application is liable to be rejected if:

- a. The proposal is not submitted as per the requirements indicated in the EOI.
- b. Not in the prescribed format.
- c. Not properly signed as per requirements.

7. EvaluationMethodology / Pre-Qualification Criteria:

The selection of law firm shall be based upon:

- b. Lowest Financial Bid; Section-II.

Sant Longowal Institute of Engineering and Technology will evaluate the firms for short listing, inter-alia based on their experience of handling similar types of work, strength of manpower of the firm. Sant Longowal Institute of Engineering and Technology will assign scores to the response of each firm based on weightage assigned to each of the criteria under different categories mentioned in Section-I (Part-B). If there is large number of applicants, the weightage will be given to those who have scored more marks.

No travelling charges or other related charges would be paid by Sant Longowal Institute of Engineering and Technology in case of bidder required to present before the expert committee.

8. Conflict of Interest:

- **a.** Where there is any indication that a conflict of interest exists or may arise, it shall be the responsibility of the bidder to inform Sant Longowal Institute of Engineering and Technology, detailing the conflict in writing as an attachment to this Bid.
- b. Sant Longowal Institute of Engineering and Technology will be the final arbitrator in cases of potential conflicts of interest. Failure to notify Sant Longowal Institute of Engineering and Technology of any potential conflict of interest will invalidate any verbal or written agreement.
- **c.** A Conflict of Interest is where a person who is involved in the procurement has or may be perceived to have a personal interest in ensuring that a particular Bidder is successful. Actual and potential conflicts of interest must be declared by a person involved in a Bid process.

9. General Terms and Conditions:

- 1. Agency must fulfill all the requirements given in the Technical Bid and terms and conditions of the tender.
- 2. The successful tenderer shall be required to execute an Agreement Deed on the format approved and supplied by this Institute on stamp papers of appropriate value. The cost of the stamp paper shall be borne by the successful tenderer.
- 3. The Director, SLIET Longowal shall have absolute right and authority for the suspension/ revocation of security/bank guarantee in case of breach of any clause of the Agreement by giving prior notice.
- 4. A penalty @ 1% of the monthly value of contract maximum upto 10% of contract value shall be imposed for non-commencement of work within the stipulated period after the issue of award letter for every week or part thereof for the delay in the commencement of the contract.
- 5. The decision of the Director, SLIET Longowal with regard to the determining of quality of work/services done by the contractor or his employees shall be final and acceptable to the contractor. The Director, SLIET Longowal reserves the right to get the work/services so rejected done/replaced at his own level at the risk and cost of the contractor after giving him a notice in writing and the expenditure incurred on this count shall be recovered from the contractor from his outstanding dues or by revocation of any or all parts of the security/bank guarantee, as he may think proper.
- 6. The contract cannot be transferred/assigned/subcontracted/subletting by the contractor to any other person/ firm.
- 7. Contractor shall pay GST, at the rates as applicable from time to time.
- 8. SLIET Longowal Right to vary Quantities by $\pm 25\%$ at the time of Award.

- 9. The Director, SLIET Longowal reserves the right at the time of Contract award to increase or decrease the area quantity of services originally specified in the tender document without any change in unit price or other terms and conditions. Further, at the discretion of the Director, SLIET Longowal, the area/ quantities in the contract may be enhanced by 25% within the contract period.
- 10. *Fraud and Corruption*: The SLIET Longowal requires that bidders, suppliers, and contractors, if any, observe the highest standard of ethics during the execution of such contracts. In pursuit of this policy,

(vi) Coercive practice" means harming or threatening to harm, directly or indirectly, persons or their property to influence their participation in the procurement process or affect the execution of a contract; 1

(b) SLIET Longowal will reject a proposal for award if it determines that Bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent collusive or coercive practices in competing for the Contract in question.

11. Interpretation of the clauses in the Tender Document / Contract Document

In case of any ambiguity / dispute in the interpretation of any of the clauses in this Tender Document, Director, SLIET Longowal interpretation of the clauses shall be final and binding on all parties.

- The Contractor shall conform to the provisions of various Central/State Act(s) or the Regulations on the subject as well as terms and conditions of the contract. He will be liable for the deduction of TDS on the total bill as per provision of the Income Tax Act, or GST as applicable from time to time.
- The Institute shall have further right to adjust or readjust or deduct any of the amounts as aforesaid from the payment to be made to the Contractor under this Contract or out of the security deposits of the Contractor.
- 12. TERMINATION OF THE CONTRACT: The contract may be terminated in any of the following contingencies:
 - i. On giving one-month notice by SLIET Longowal. OR
 - ii. On the expiry of the contract, without any notice. OR
 - iii. On giving one-month notice by SLIET Longowal at any time during the tenancy of contract, in case the services rendered by the contractor are not found satisfactory and in conformity with the terms and conditions of the contract and the standard prescribed for these services. OR
 - iv. On assigning of the contract or any part thereof or any benefit or interest therein or there under by the contractor to any third party for sub-letting the whole or a part of the contract to any third party. OR
 - v. On contractor being declared insolvent by the competent Court of Law without any notice.
 - vi. The contract can be terminated at any point of time without assigning any reason in between, if it is found that the services rendered by the agency are not satisfactory.

In case of termination of contract on the grounds mentioned at Sr. No iii & iv above OR in case of contractor decides to conclude the contract before the expiry of initial

twelve months contract period, the Institute shall forfeit the Bank guarantee and the contractor shall not have any claim/right against the Institute.

In case of extension beyond initial period of one year, contractor will have an option to conclude the contract by giving three months' notice in writing during the contract period.

Provided that during the notice period for termination of the contract, in the situation stated above, the contractor shall keep on discharging his duties as before till the expiry of notice period on existing terms conditions.

- 13. LAST PAYMENT: The last payment of the contractor will be cleared only after obtaining clearance of any liabilities not pending.
- 14. JURISDICTION: The contract will be subject to Chandigarh Jurisdiction, In case of any dispute, only Chandigarh Court will have jurisdiction.
