In absence of non submission of this certificate, payment towards GST may not be considered.


6. **Institute's GST number is 03AAAAL6685R1ZZ which must be clearly mentioned in the e-way bill & tax invoice.**

10. Non acceptance of this order shall be conveyed to us within 15 days of its receipt, failing which unconditional acceptance thereof by you will be deemed conclusive.


