

Further, Director SLIET informed that comments of the Joint Secretary & Finance Advisor, GoI, MoE, IFD has also been received vide Letter No. F. 2-5/2013-IFD (Pt.) dated 17.10.2024.

ITEM NO. 52.01	DECISION OF THE HON'BLE HIGH COURT OF PUNJAB AND HARYANA IN CWP NO. 2110 OF 2021 TITLED AS "AMARJIT SINGH VERSUS BOARD OF MANAGEMENT, SANT LONGOWAL INSTITUTE OF ENGINEERING AND TECHNOLOGY, LONGOWAL, DISTRICT SANGRUR (PUNJAB) AND ANR".
	<p>The BoM was apprised in detail about the case of Sh. Amarjit Singh, who was awarded compulsory retirement and the reasons thereof, by the Director and the Registrar. The Registrar also presented a PPT, highlighting the timeline of the event that led to the compulsory retirement and subsequent cases in the Hon'ble High Court of Punjab & Haryana, Chandigarh. The Registrar apprised the BoM that it will cost around 1.5 Lacs to 5.00 Lacs towards the expenses to hire advocate and file the case in the Hon'ble Supreme Court of India. He also informed that expenses may also increase subject to number of hearings. He further informed that it will cost an additional fee of at-least Rs.2.5 Lacs more per hearing to engage Additional Solicitor General Ms. Aishwarya Bhati.</p>
	<p>The Board members discussed the matter in details and finally directed the Institute to file an SLP in the Hon'ble Supreme Court of India. Various options were also discussed regarding engagement of advocates to handle the case in the Hon'ble Supreme Court. The Board authorized the Director, SLIET to engage a suitable Lawyer in this matter and engage Additional Solicitor General Ms. Aishwarya Bhati as per requirement.</p>
