BoM was informed that this matter was placed before the Board in its earlier meetings held on 17.10.2024, 28.10.2024 and 18.12.2024 for resolution.

BoM noted that there are no administrative lapses on the part of the Institute as the decision of not to reinstate Sh. Amarjit Singh was taken by the BoM itself in its 39th meeting held on 10.11.2020 and its earlier meetings and the Institute has been regularly following up the matter with Hon'ble High Court and Supreme Court and doing its best.

BoM had directed the Institute in its 54th meeting held on 18.12.2024 to send the matter to MoE for their advise and accordingly letter was sent to MoE.

BoM was also informed that this matter came up for hearing on 20.12.2024 and Hon'ble High Court of Punjab & Haryana was very harsh on the Institute authorities for non-compliance with their order issued on 09.08.2024. During hearing on 20.12.2024, Hon'ble High Court gave only 2 hours time to the Institute to decide whether Institute was going to comply with its order or not.

Matter was immediately discussed with the Director (T), MoE and the Joint Secretary (TEL) over the phone by the Director, SLIET. As per their verbal orders to comply with the orders of the Hon'ble High Court, Institute gave an undertaking to the Hon'ble High Court that Institute shall comply with the order of Hon'ble High Court.

Accordingly, Sh. Amarjit Singh was reinstated as Section Officer vide office order No. SLIET/Admn/A2/2024-25/4986 dated 20.12.2024 and he joined his duties on 26.12.2024 afternoon.

BoM was also informed that legal advice from the Legal Counsel for making payment of Sh. Amarjit Singh dues/arrears was taken and he was paid 50% of his dues after deduction of applicable income tax and CPF share amount as per legal advise after taking undertaking from Sh. Amarjit Singh and Surety Bond from another employee.

During the hearing on 20.12.2024, Hon'ble High Court was informed that Institute had filed SLP before the Hon'ble Supreme Court of India. Considering this, the Hon'ble High Court directed the institute to deposit cheque for balance 50% amount (Rs. 26,77,141) with the legal counsel (DSG) and same was complied with.

BoM was also informed that institute had filed SLP in the Hon'ble Supreme Court of India and this matter was heard on 15 Jan 2025. Hon'ble Supreme Court of India stayed the order of Hon'ble High court of Punjab & Haryana.

This matter again came up for hearing in the Hon'ble High court of Punjab & Haryana on 20 Jan 2025. Hon'ble High Court ordered to release back the cheque to the institute that was kept by the DSG and same has been received back by the institute.

BoM was also informed that a letter has been issued to Sh. Amarjit Singh to pay back the amount of Rs. 26,77,141 already given to him. Sh. Amarjit Singh has requested the institute to give him 20 days time to decide upon this.

As per the legal advise given by Deputy Solicitor General in Hon'ble High Court of Punjab & Haryana, this matter about continue/discontinue of services of Sh. Amarjit Singh needs to be taken and decided by the BoM.

BoM was also informed that next date of hearing in Hon'ble Supreme Court is scheduled for 4 Mar 2025 and Sh. Amarjit Singh shall be superannuating on 31.03.2025.
