



## **TERMS AND CONDITIONS FOR ENGAGEMENT OF ADVERTISING AGENCY ON DAVP RATES**



The intending agency must fulfil the following eligibility criterion:

1. The agency must be fully accredited with Indian Newspaper Society (INS). The agency should be in advertising business for at least 05 years after accreditation.
2. The agency's annual turnover for the last three Financial Years should be minimum Rs.1.00 crores each year, with adequate proof from Chartered Accountant. Copies of Audited Balance Sheet for the financial year 2023-24,2024-25 and 2055-26 are required to be submitted.
3. The agency must have Empanelment/Engagement with atleast 03 Government Departments / Institutes / Universities. (sufficient proof must be enclosed) during the last 3 years upto 31.03.2026.
4. The agency should have complete infrastructure in designing, media and marketing department.
5. The agency shall submit an affidavit (as per Annexure A) declaring that his firm/company has not been blacklisted by any Government department or an autonomous body.
