**OFFICE ORDER**

The terms and conditions are as under:

1	Working Days & Working Hours	:	<ul style="list-style-type: none"><li>• Tuesday to Sunday (3-4 hours per day &amp; up to 06 days a week as per requirement of SLIET) except Ms. Meena Rani.</li><li>• Ms. Meena Rani (Arts and Craft Trainer), Tuesday to Sunday (3-4 hours per day &amp; up to 02 days a week as per requirement of SLIET).</li></ul>
2	Honorarium (*)	:	Rs. 1,050/- (Rs. One Thousand fifty Only) per day subject to a maximum of Rs.27,300/- (Rupees Twenty seven Thousand three hundred only) per month.
3	Accommodation	:	Accommodation may be provided as per eligibility and availability of quarters in the Campus.
4	Leave	:	Not applicable
5	Duties	:	As assigned to you by the institute authorities from time to time.
6	Resignation/ Termination	:	Your services can be terminated by giving a notice of 07 days, without assigning any reason. You may also terminate your engagement with the Institute by giving seven days' notice or pay in lieu thereof.
7	Deduction	:	A deduction of Rs. 1000/- out of the monthly honorarium will be made every month. The refundable security amount so collected will bear no interest and will be payable at the end of the tenure, after the submission of No Dues Certificate (concerned Dept., Estate Office, Hostel, Library and Accounts).
8	Nature of Engagement	:	This is purely a casual engagement as a short-term arrangement and will not bestow any right on you for claiming continuation in casual period beyond the period specified above.

\* A 5% increase in the honorarium is subject to the approval of the Board of Management (BoM). If the same is not approved by the BoM, the increased amount already paid shall be recovered by adjusting it against the security deposit amount deducted from above mentioned coaches /trainers.
